# Liposuction of the chin

### Indications

If you are relatively young and you are annoyed by a double chin, which you cannot get rid of, then liposuction chin-the solution for you. It will radically save you from the problem of double chin and give a clear contour to the oval face.

Double chin can appear as a result of different reasons. It can be sagging skin caused by aging or weight loss. Liposuction in this case is not the best solution.

If the double chin appeared due to weight gain, age or this form of chin is due to genetic reasons, then liposuction in this case will be very effective.

The so-called "gentle liposuction" is well suited for the face, because the amount of fat withdrawn is minimal, and after the procedure there are almost no noticeable traces, and the patient can immediately return to a normal lifestyle.

Before surgery, the doctor examines the patient, in particular, the quality of his skin.

The patient should clearly state his problem and expectations from the operation. The doctor explains the details of the upcoming operation, the expected result, possible errors of the result and potential risks. The surgeon should make sure that there are no contraindications for liposuction and determine the optimal plan to solve the aesthetic problem of the patient.

After that, the 15-day interval between the first consultation and the day of surgery should be observed. This is necessary, first, so that the patient's consent to the operation was not a spontaneous whim, but a deliberate and balanced decision.

#### Surgery

The surgeon using a surgical marker marks on the neck area for the upcoming liposuction.

For better suction of fat, and that the procedure was less painful, produce infiltration of saline to liquefy fat.

The surgeon then makes small thin incisions in the natural folds of the neck. Through these he introduces a very thin special cannula with a rounded tip perforated at the end.

The fat aspiration system connected to the cannula allows to suck out the fat cells located in the double chin, previously destroyed by mechanical movements of the cannula back and forth.

Then the incisions are closed with absorbable thread and sealed with a plaster. Minor scars may remain, but they are hidden in the natural folds of the neck.

# • Anesthesia, duration of surgery, hospitalization

Double chin liposuction is performed under local anesthesia. Because the amount of fat sucked out on the chin is small compared to other areas of fat accumulation, such as the hips or sides, chin liposuction lasts less than an hour.

The operation is performed on an outpatient basis, that is, there is no need to stay in the clinic overnight.

## • Chin liposuction price

There is no single tariff for double chin liposuction. The price depends on the surgeon's fees, the conditions of the operation and the amount of fat extracted.

These are the facts which we wish to bring to your attention, to complement what you were told during the consultation.
